Our work on future fuel designs

Medium-term: Ammonia & Hydrogen fuel designs

- Ammonia-ready bulk carriers (designed by Anglo-Eastern) for zero-cargo loss:
- LR approval in principle (IMO Type A tanks),
- ABS approval in principle (IMO Type C tanks)
- DNV approval in principle for a 2,000KW ABC H₂ Generator retrofit: 1,900 TEU vessel.
- Concept design, plan approval and site supervision of a hydrogen-powered tug



Long-term

Anglo-Eastern has partnered with CORE-POWER a Marine – Molten Salt Reactor (m-MSR) Development Company, as we believe that Nuclear Energy is the key to a truly zero emission concept. We are working with "CORE" to develop a practical ship design based on m-MSR as the energy source.
